

Aperol Sweepstakes for 2025 US Open Tickets
Official Rules

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, ENTRANTS AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Aperol Sweepstakes for 2025 US Open Tickets ("Sweepstakes") is open only to individuals who are legal residents and physically located in one (1) of the fifty (50) United States or the District of Columbia, and who are at least twenty-one (21) years of age or older as of time/date of entry. Employees, officers and directors of Campari America, LLC ("Sponsor"), TPN Holdings LLC, Realtime Media LLC ("Administrator") and each of their respective parents, affiliates, subsidiaries, representatives, shareholders, members, agents, employees, subcontractors, and their respective advertising, sweepstakes, contest, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), suppliers, distributors, wholesalers, or retailers of alcohol-beverage products, as well as the employees, officers, and directors of United States Tennis Association Incorporated ("USTA"), USTA National Tennis Center Incorporated ("NTC"), and their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. By participating, you agree to these Official Rules and to the decisions of the Sponsor and Administrator, which are final and binding in all respects. Void where prohibited by law, rule or regulation. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these "Official Rules" and the decisions of Sponsor, including the interpretation of these Official Rules and its exercise of discretion, which will be final and binding in all respects.
2. **TIMING:** The Sweepstakes begins on or about 12:00:00 p.m. (noon) Eastern Time ("ET") on July 10, 2025, and all entries must be received by the Sponsor on or before 11:59:59 p.m. ET on August 9, 2025 (the "Sweepstakes Period"). The designated computer clock of the Administrator is the official time-keeping device in the Sweepstakes.
3. **HOW TO ENTER:** There are three (3) methods of completing an online registration form for a total of one (1) online registration entry per entrant regardless of method of entry and one (1) method for obtaining bonus entries via Sweepstakes share (up to ten [10] total bonus entries per entrant) if you enter via the Sweepstakes Microsite, as described below:

Complete Online Entry Form (see limit below):

- a) **Sweepstakes Website:** During the Sweepstakes Period, visit <https://tennissweepstakes.aperol.com/us/> ("Website") and follow the links and instructions to

complete and submit an official entry form including your full name, valid email address, date of birth, and any other required entry information, to be eligible for entry. Once you have done so, you will receive one (1) entry into the Sweepstakes, subject to the limit below.

- b) **Via Meta (Facebook) Lead-Gen Advertising Invitation:** During the Sweepstakes Period, if you are eligible and are invited via an advertisement by Sponsor to enter the Sweepstakes via a registration form on Meta (Facebook), follow the call to action by clicking on the ad, clicking next, allowing the form to auto-populate with your information, clicking next, optionally checking a box to opt in for marketing, then seeing the confirmation of your entry. Once you have done so, you will receive one (1) entry into the Sweepstakes, subject to the limit below.
- c) **Via Instagram Lead-Gen Advertising Invitation:** During the Sweepstakes Period, if you are eligible and are invited via an advertisement by Sponsor to enter the Sweepstakes via a registration form on Instagram, follow the call to action by clicking on the ad, clicking next, allowing the form to auto-populate with your information, clicking next, optionally checking a box to opt in for marketing, then seeing the confirmation of your entry. Once you have done so, you will receive one (1) entry into the Sweepstakes, subject to the limit below.

If You Entered Via the Website - Sweepstakes Share Method of Obtaining Bonus Entries:

After entering via the Website, you may obtain bonus Sweepstakes entries ("Bonus Entries") by using the share functionality provided to post a prepopulated message promoting the Sweepstakes on your X or Pinterest Account to invite a friend (who also must be eligible per Section 1, above) to enter the Sweepstakes. For each share message sent using the share functionality provided by Sponsor where the individual who receives the message enters the Sweepstakes using the link provided, you will receive one (1) Bonus Entry into the Sweepstakes, up to a maximum of ten (10) Bonus Entries (up to five [5] Bonus Entries via X and five [5] Bonus Entries via Pinterest share). You are not permitted to invite anyone under the age of 21 or anyone not eligible for this Sweepstakes.

Limit of one (1) entry per entrant for completing an online entry form during the Sweepstakes Period (regardless of method or combination of methods of entry), and up to ten (10) total Bonus Entries, per entrant, as described above. Subsequent attempts made by the same individual to submit more than the stated number of entries by using multiple or false contact information, accounts, or otherwise may result in the entrant being disqualified. Entries generated by a script, computer program, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the registered account holder of the email address associated with the entry, provided that person is eligible. Potential winners may be required to show proof of being registered account holders. Registered account holder is defined as the person assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. In the event that a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified.

- 4. **SWEEPSTAKES DRAWING:** There will be three (3) potential winners selected in this Sweepstakes, via a random drawing on or about August 11, 2025, from all eligible entries received in accordance with

these Official Rules. The Sponsor and Administrator will have complete discretion over interpretation of the Official Rules, the administration of the Sweepstakes, and the selection of potential winners. Decisions of the Sponsor and Administrator as to the selection of the potential winners will be final and binding.

5. **ODDS:** Odds of winning a prize will depend on the total number of eligible entries received during the Sweepstakes Period.
6. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified using the email address provided during entry in a commercially reasonable time after the drawing. The Sweepstakes Parties are not responsible for false, incorrect, changed, incomplete, or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email. As part of the winner notification process, each potential winner will be required to complete and submit a declaration of eligibility / release of liability / prize acceptance agreement (collectively, the "Declaration") within two (2) calendar days as a condition of receiving a prize. If a potential winner fails or refuses to sign and return the Declaration within the required time or if the Declaration is returned as rejected, faulty, unclaimed, or returned as undeliverable to potential winner, potential winner will be disqualified. P.O. Boxes are not permitted. The Sweepstakes Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email or other account to receive messages. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the prizes set forth in these Official Rules, the winners of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prizes. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. The Sweepstakes Parties are not responsible for and shall not be liable for late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify the potential winners.

7. **PRIZE/PRIZE RESTRICTIONS/APPROXIMATE RETAIL VALUES ("ARV"):** One (1) Grand Prize ("Grand Prize"), one (1) First Prize ("First Prize"), and one (1) Second Prize ("Second Prize") will be awarded in this Sweepstakes.
 - **One (1) Grand Prize:** One (1) Grand Prize consisting of: Two (2) courtside tickets for the winner and one (1) guest who is at least 21 years of age (two (2) tickets total) to attend the US Open Tennis Championships (the "Event") men's finals on September 7, 2025. Exact seat location and all details to be determined by the Sponsor. Grand Prize also includes an Aperol gift pack*, a check in the amount of \$2,032 that can be used to help offset, but not completely eliminate the tax liability associated with prize acceptance, and a \$750 prepaid card. Prepaid card terms and conditions apply.

The ARV of the Grand Prize is \$7,837.

- **One (1) First Prize:** One (1) First Prize consisting of: Two (2) loge tickets for the winner and one (1) guest (two (2) tickets total) to attend the Event - Quarter Finals on September 3, 2025. Exact seat location and all details to be determined by the Sponsor. First Prize also includes an Aperol gift pack*, a check in the amount of \$670 that can be used to help offset, but not completely

eliminate the tax liability associated with prize acceptance, and a \$750 prepaid card. Prepaid card terms and conditions apply.

The ARV of the First Prize is \$2,641.

- **One (1) Second Prize:** One (1) Second Prize consisting of: Two (2) courtside tickets for the winner and one (1) guest (two (2) total tickets) to attend the Event – first round evening session on August 24, 2025. Exact seat location and all details to be determined by the Sponsor. Second Prize also includes an Aperol gift pack*, a check in the amount of \$641 that can be used to help offset, but not completely eliminate the tax liability associated with prize acceptance, and a \$450 prepaid card. Prepaid card terms and conditions apply.

The ARV of the Second Prize is \$2,173.

The US Open schedule of play as well as session dates, number of matches and starting times (and the opening of venue gates) are subject to change by USTA/NTC in its sole discretion, and no such change shall entitle winner to a refund or any other remedy if winner cannot attend the US Open (or any session thereof) or for any other reason. Event tickets are subject to all ticket terms and conditions, as well as all venue and US Open procedures, policies, protocols and mitigation measures, including, without limitation, security and guest conduct, health and safety, and applicable bag policies, and ticket holders must comply and abide by all such terms, conditions, procedures, policies, protocols and mitigation measures.

Tickets will be transferred to each winner digitally via Ticketmaster and winner must create a Ticketmaster account to receive tickets. Each winner and guest must attend the Event on the dates specified by the Sponsor above.

TRAVEL AND ACCOMMODATIONS ARE NOT INCLUDED IN ANY PRIZE AND ARE AT THE EXPENSE OF THE WINNERS. WINNERS ARE RESPONSIBLE FOR ANY ALL TRAVEL TO AND FROM THE EVENT AND ANY ACCOMODATIONS IN CONNECTION WITH THE EVENT.

Total ARV of all prizes available in the Sweepstakes is \$12,651.

No part of any prize includes any alcoholic beverages.

*The Aperol gift pack includes branded tennis themed swag as determined by Sponsor in its sole discretion.

Any other expenses or items not specifically listed, including, but not limited to, air travel, ground transportation, accommodations, meals, parking and souvenirs, are the responsibility of winner and/or winner's guests. Each guest must be twenty-one (21) years or older. Winner is strictly prohibited from selling, auctioning, trading or otherwise transferring the tickets unless Sponsor consents in writing. If the ticketed event or any portion thereof is postponed, rained out, canceled, or for other reasons beyond Sponsor's and organizers' control does not occur, the Sponsor and organizers will not be responsible for replacing the ticketed portion of prize. Tickets are subject to certain terms and conditions specified thereon, and seat locations (if any) are solely determined by Sponsor and organizers. Lost or stolen tickets or passes will not be replaced. The Sponsor and organizers shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the venue operator, prize provider or any other persons providing any prize-related services. If travel delays, cancellations or difficulty prevent arrival in time for the Event, the Sponsor and organizers (or other Released Parties) are not responsible for awarding any compensation in lieu thereof. Tickets must be

redeemed as stated in the prize notification or otherwise stated in the Official Rules. Winners agree to accept all space availability requirements established by the venue. Winners and guests must comply with all applicable laws, and any rules and regulations established by the venue. Sponsor, organizers, and the applicable venue representatives reserve the right to remove or to deny entry to any winner (and guests) who engage in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the event or in any other objectionable behavior. Sponsor reserves the right to terminate the applicable experience early. Winner acknowledges that, notwithstanding the safety precautions taken by the venue, and other providers of services related to the prize, it is possible that he/she may still contract Coronavirus (COVID-19). Additionally, winner understands and agrees that, in response to economic and/or social conditions engendered by the Coronavirus (COVID-19), Sponsor or organizers may be compelled to modify, postpone or cancel the event. In all cases, winner releases and agrees to hold harmless Sponsor, organizers (as well as the other Released Parties) from any and all liability in conjunction therewith and, in no event, shall Sponsor, organizer (as well as the other Released Parties), have any liability in excess of the above-indicated ARV of the prize. The prize winner and guests must conduct themselves at all times in a socially responsible, respectful and appropriate manner including following all private guidance from venue operator and other prize suppliers as well as governmental mandates intended and designed to prevent contracting and/or spreading COVID-19/Coronavirus; which may include but are not limited to maintaining social distancing, mask-wearing, testing and may also include quarantine (if mandated).

Prizes are non-transferable, with no cash redemptions, equivalents, or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and prize provider's rules and restrictions, and in the event that Sponsor is unable to provide winners with a prize, the Sponsor may elect to provide winners with the approximate value of such item in cash or award an alternate prize of comparable or greater value. Prize is awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Winners will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prize received, regardless of whether they, in whole or in part, are used. The ARV of a prize is based on available information provided to Sponsor and the value of the prize awarded will be reported for tax purposes as required by law. Each winner will be required to provide Sponsor with a valid social security number before the prize will be awarded, for tax reporting purposes. An IRS Form 1099 will be issued in the name of winner, for the actual value of the prize received. Any unclaimed prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated or stolen prize or any prize that is undeliverable or does not reach the winner because of an incorrect or changed address. If winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Sweepstakes Parties will have no further obligation with respect to that prize.

Such Advertising shall be solely under the control of Sponsor and/or its licensors, and winner hereby waives any claim of control over the Advertising content as well as any possible claims of misuse of such winner's Likeness under contract, tort or any other theory of law. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner.

10. RELEASES: All entrants, as a condition of participation in this Sweepstakes, agree to release, discharge, indemnify and hold harmless the Sweepstakes Parties, USTA, NTC, the City of New York, X, Pinterest, Meta (Facebook), Instagram, and each of their respective directors, officers, employees, agents, successors, and assigns, (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees), losses, damages, fines, or actions of any kind whatsoever for injuries, damages, or losses to persons or property (including death) which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of any prize awarded, including any travel or activity associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) entrant's registration material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.

12. GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws in the State of New York, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.
